

Legal basis of the Raffle “Two double grandstand tickets for the Michelin® Grand Prix of Styria and Two double grandstand tickets for the Motorrad Grand Prix von Österreich”

The company **E-SOLUTIONS INSITEOUT, S.L** Domiciled in Plaza Pau Vila 1, 2da planta ofc 2D3, 08039 - Barcelona (Barcelona) y C.I.F **B-65331530** (onwards “Insiteout”) for promotional purposes, organizes the raffle of **Two double grandstand tickets for the Michelin® Grand Prix of Styria and Two double grandstand tickets for the Motorrad Grand Prix von Österreich** (onwards, the “Promotion”) on an international level, developing through the web, in accordance with what is established in these terms and conditions.

LAY OUT

I- DURATION OF THE RAFFLE

The Promotion will initiate on the day 09-07-2021 and will end on the day 25-07-2021, both days included.

II- PROMOTION REQUIREMENTS AND MECHANICS

The requirements to participate in the promotion will be the following:

- a) Everyone, without age limitations, will be able to participate if they meet the requirements set forth in this article.
- b) The participation will be formalized when a purchase is made on the website www.store.motogp.com, for a minimum value of 100 euros (€) , GBP 100 (£) , USD 100 (\$) or JPY10,000 (¥) within the dates specified in the article I and express acceptance of the conditions of this Promotion in the section of the shopping cart destined for this purpose.
- c) The participants will be able to register many times in this Promotion considered one participation for each purchase under the previously mentioned assumptions. Therefore, the participation in the draw will be of one or several participations per natural person, depending on the number of purchases made.
- d) The personal information in which participants make the purchase must be truthful, and will authorize Insiteout to carry out any verification of identity, age and data.

The mechanism of this promotion is based on:

There will be a draw for 2 Michelin® Grand Prix of Styrian double tickets valued at 100€ each and another draw for 2 Motorrad Grand Prix von Österreich double tickets valued at 100€ each.

2 winners (the "Winners") and 4 substitutes (the "Substitutes") will be selected in the draw on 26/07/2021. The winners will be contacted by Insiteout, either by a message to the email address provided by the winners, or by a phone call to the number provided by the winners, informing them that they have won. If a winner does not contact Insiteout to accept the prize within 1 day from the sending of the email by Insiteout, he/she will be deemed to have refused the prize. In this case, the prize will be awarded to the first substitute. If the substitute does not contact Insiteout for the prize within 1 calendar day of the sending of the email by Insiteout, it will be deemed to have rejected the prize. In this case, the draw will be carried out again with the initial database of the participants of the Promotion, under the same mechanics exposed in this article.

The raffle will be made through the specialized platform Easypromos. Emitting a validation certificate that will guarantee the random nature of the draw.

The prizes are non-transferable, they cannot be challenged or claimed, nor can they be exchanged for money.
